the unemployed between March 2008 and March 2009, while the national unemployment rate for men was 9.5 percent compared to 7.5 percent for women.

And how has this "man-cession" played out in Montana? Interestingly, our state's unemployment rate gap between men and women of about 4.5 percentage points is actually double that of the national unemployment gap. The disproportionate recession impacts on men may have occurred because of industry and occupational differences between the genders.

At the 35th Annual Economic Outlook Seminar, Wendy Stock, department chair of Agricultural Economics and Economics at Montana State University, will discuss the recession's impacts, economic recovery, and workforce issues.

This half-day seminar and luncheon will highlight the latest economic trends and

forecasts for the nation, state, and local-area economies. Bureau economists Patrick Barkey and Paul Polzin will present economic outlook forecasts for each seminar city, and industry experts will provide the outlook for Montana's important industries: nonresident travel, housing, health care, agriculture,

manufacturing, and forest products. Montana Kids Count will present a luncheon program on investments in early childhood education.

The program is presented by the University of Montana's Bureau of Business and Economic Research and the Kalispell Chamber of Commerce. The Cost of \$80 includes the seminar, a proceedings booklet, lunch, and one year subscription to the Montana Business Quarterly, the state's award-winning business journal (a \$35.00 value). # The focus of January's Leadership Flathead's session was "Healthcare and Human Services."

But before delving into the day's agenda, Deb Snellen of Business Class led the Class of 2010 through a crash course in negotiating

skills. Deb is spending the year with the Class of 2010, facilitating monthly skills building sessions and contributing insight from her 16-plus years working with Leadership Springfield in Missouri.

Over the course of the day, the class heard from two healthcare panels and two human services panels. It's always shocking to hear how much uncompensated care our two local hospitals incur each month. Jason Spring of North Valley Hospital estimates his hospital's annual charity care at around \$15 million. The cost of uncompensated care is passed on to those with the ability to pay for their health care. Dr. David Keim of Glacier Dental Group addressed the class about the difficulties in providing dental care for the uninsured and underinsured. Because Medicaid does not cover the overhead of costs of treating a patient, most dentists will

not see Medicaid patients. Dr. Keim and a handful of other local dentists do treat some Medicaid patients, but the responsibility needs to be spread more evenly. The Flathead Community Health Clinic is a good start toward treating the needs of those without adequate dental coverage.

Here are some things you may be able to do to advance "Healthcare and Human Services" in the Flathead Valley:

- Visits to the Samaritan House and the Flathead Food Bank were a reality check. According to Lori Botkin of the Flathead Food Bank, the number of people relying on the food bank has doubled since the agency moved into its new location in the old Gateway West Mall in October. Now more than ever, we all need to contribute what we can... our time, our talent, our ideas, our compassion, and if we have it, our money.
- Shop locally! Use local healthcare services rather than traveling to

Property tax increases in the Flathead are significantly higher than were projected during the 2009 session and action is being taken on several fronts to mitigate these impacts. ### Transportation Explores Added Commercial Air Service

The Transportation Committee was briefed on the potential addition of Frontier Airlines to the mix at Glacier Park International Airport. And, a meeting to review answers to the November scoping meeting questions will be held on January 25.

in revitalizing the economy and how Americans can benefit from and advance the initiative.

Addressing a roomful of Kalispell business leaders at the Hilton Garden Inn for the first monthly chamber luncheon of the year, Renee Radcliff Sinclair, Northwest Regional Director of Congressional and Public Affairs for the U.S. Chamber of Commerce, estimated 19,203 jobs have been lost in Montana since the start of 2008.

To stay even with growing population, 23,441 jobs need to be created in Montana within the decade to offset that loss, with about 5,000 of them here in the Flathead Valley, according to Kalispell Chamber President Joe Unterreiner. That number pales in comparison to the 20 million jobs Sinclair indicated need to be created nationally.

"We have the ability to do it. We've done it before and we can do it again," she said. Government can support the effort by doubling exports to combat trade deficits and also by creating jobs to fix government infrastructure, notably water and wastewater, highway maintenance, airport expansions and energy production, she said.

Increasing access to credit, reigning in taxes and bolstering the educational system would fuel small businesses, offering extra dollars to expand business. Sinclair maintained that rescinding funding from schools is "artificially placing a cap on our economy" by weakening the number of educated and skilled workers available.

But even if government support is attained in those key areas, innovation within the small-business community is key to economic stability, she said. "We all know it's the private sector that creates jobs," she added.

Much of the free-enterprise campaign is geared toward energizing that very private-sector community. With online video competitions for small-business owners and a Dream Big Small Business Award to be given at the end of the year, the U.S. Chamber hopes to attract grassroots support from business leaders across the country. So far, more than 400,000 businesses have pledged their support for the initiative. More information on the campaign and how to get involved can be found at www. FreeEnterpriseAmerica.com.

Following Sinclair's address, outgoing Kalispell Chamber Board President Bob Schneider outlined some of the 2010 projects the local chamber is using to combat job loss.

At the top of the list is establishing a tourism business district, a project already in the works.

"Tourism is a big part of employment in the Valley. It's our one shining spot right now," he said. The tourism business district will unite hotel owners and provide revenue to fund projects. The local chamber is also putting significant resources into exploring the production of biomass energy in the wake of the recent Smurfit-Stone Container plant closure in Frenchtown. Schneider alluded to the additional jobs lost in the trickle-down effect of the plant closure.

Each project will focus on combating joblessness in the Flathead Valley. "Job creation will be our priority," he reinforced.

### Flathead County Cost-of-Living Figures for 2009 Released

Information released by the Kalispell Chamber of Commerce revealed that cost-of-living in the Flathead County is 1.5 percent above the national average.

The Flathead County cost-of-living index measures differences between areas in the cost of consumer goods and services, excluding taxes and non-consumer expenditures. It is based on more than 60 items for which prices are collected quarterly. Local data is combined with information from 322 other communities to create the ACCRA Cost of Living Index. ACCRA is the national association of community and economic research professionals. Other Montana areas participating in the survey include Bozeman and Missoula.

The ACCRA Cost-of-Living Index for the Kalispell for the annual average of 2009 is as follows (average of 322 total urban areas = 100):
